PRAYER :-

C-58B. For Bail in Crime No.9 of 2021 on the file of the
Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the
respondent police for the offences punishable under sections 363 and
506(ii) I.P.C and Sections 3(a), 4(2), 5(1), 6(1) of POCSO
(Amendment)Act, 2019 in Crime No.9 of 2021 on the file of the
respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner called
the victim girl over phone and asked her to come out from the house.
Thereafter, he took her in the two wheeler and committed sexual
assault. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the
petitioner is innocent and he has not committed any offence as
alleged by the prosecution.

4.It is the specific case of the prosecution that the victim
girl is aged 13 years and the petitioner/accused is 21 years.



5.Considering the seriousness and graivity of the offence alleged and aslo considering the statement recorded under Section 164 Cr.P.C from the victim girl, this Court is not inclined to grant bail to the petitioner at this point of time.

6.In view of the above, this Criminal Original Petition is dismissed.
