PRAYER:

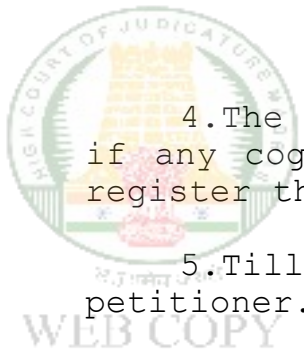
For Anticipatory Bail in Crime No. not known of 2021 on the file of the respondent police.

3.The learned Additional Public Prosecutor appearing for the respondent police would submit that the petition enquiry is pending in CSR No.1086/21 on the file of the respondent Police.



4.The respondent police is directed to conduct the enquiry and if any cognizable offence is made out as against the petitioners, register the F.I.R or close the petition enquiry.

5.Till such time, the respondent Police shall not arrest the petitioner.
