PRAYER :-

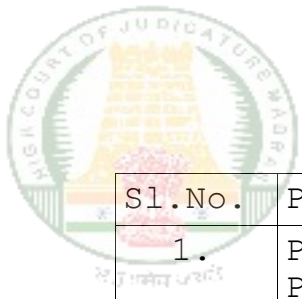
For Bail in Crime No.682 of 2021 on the file of the respondent police.

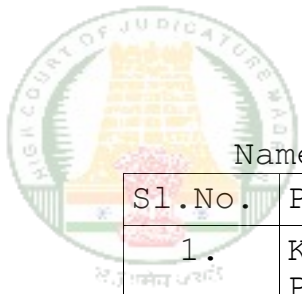
2.The case of the prosecution is that on 23.09.2021, the petitioners waylaid the defacto complainant and his son and robbed a sum of Rs.500/- at knife point. Hence, the complainant.

3.It is reported by the learned Additional Public Prosecutor appearing for the respondent that apart from this case, the first petitioner is having seventeen previous cases and the second petitioner is having twenty four cases to their credit which reads as follows.



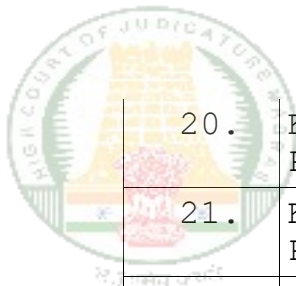
