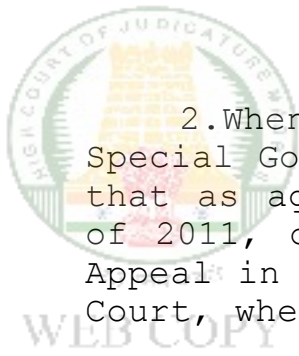
Prayer in WP(MD). 7033/ 2011 :
