Prayer :-

Civil Miscellaneous Appeal filed under Section 173 of Motor Vehicles Act, 1988 to set aside the order and decree dated 01.02.2012 passed in M.A.C.O.P No. 148 of 2009 on the file of the Motor Accident Claims Tribunal, Sub Court Kulithalai.

DECREE:- This Civil Miscellaneous Appeal having come up for final hearing on Friday the Twenty Second day of October Two Thousand Twenty One upon perusing the grounds of Appeal, the order of the Tribunal and the material papers to the Appeal and upon hearing the arguments of Mr.N.Dilipkumar, Advocate for the Appellant and none appeared of Respondents 1 and 2; having stood over the consideration till this date this Court while dismissing this appeal, doth order and decree as follows:-

(1)That the appellant /Insurance company is directed to deposit Rs.1,92,770/- (Rupees One Lakh Ninety Two Thousand Seven Hundred and Seventy Only) with 7.5% interest from date of claim petition till the date of realization and the amount if not deposited earlier has to be deposited within a period of 8 weeks from the date of receipt of copy of this order;

(2)That on such deposit the claimant is permitted to withdraw the award amount with proportionate interest after deducting any amount received by him earlier;

(3)That excess amount if any deposited shall be refunded to the appellant;

(4)That the claimant is hereby not entitled for interest for default period if there is any and;



(5) That there be no costs in this Civil Miscellaneous Appeal.
