Both the writ petitioners seek Mandamus directing the official respondents (i.e.,) R1 to R3 to grant qualification approval and consequential approval of their appointments as lecturers in Sarah Tucker College, Palayamkottai, Tirunelveli District.

The learned counsel for the fourth respondent/University would submit that pending the writ petition, qualification approval has been granted by Manonmaniam Sundaranar University on 13.03.2019 and the petitioners appointments' have also been consequently approved by the third respondent/Joint Director of College Education on 11.03.2020.
