of the respondent Police.

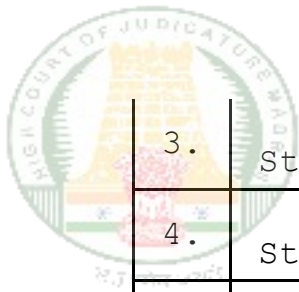
ORDER : The Court made the following order :

The petitioner, apprehending arrest for the offence under
Section 379 IPC and Section 21(1) of Mines and Minerals (Development
and Regulation) Act, 1957 in Crime No.424 of 2021 seeks anticipatory
bail.

2.The prosecution case is that the petitioner has illegally
transported one unit of river sand. Hence the complaint.

3.When the matter is taken up for hearing the learned
Government Advocate (Crl Side) appearing for the respondent
submitted that the petitioner has involved in the following four
previous cases.

5.	Adirampattinam Station Cr.No.70 of 2020	Sections 353, 379 IPC and 21(1) of Mines and Minerals Act
6.	Pattukkottai Taluk Station Cr.No.424 of 2021	Sections 379 IPC r/w 21(1) of Mines and Minerals Act

4.Considering the antecedents of the petitioner that he is involved in six previous cases, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this petition stands dismissed.
