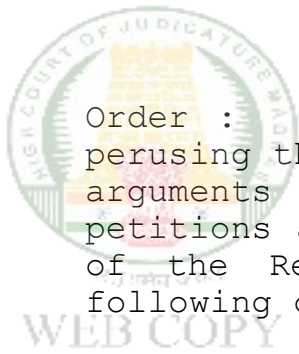
Prayer in CRL MP(MD). 9036/ 2021 in Crl.A(MD)No.150 of 2020:
