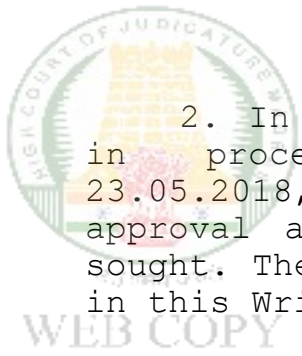

O R D E R

The petitioner has prayed for issuance of writ of mandamus directing the District Educational Officer/fourth respondent to approve forthwith the appointment of one K.Aravind Kumar as the Record Clerk in the petitioner school.
