Recording the aforesaid submissions, the Writ Petition is dismissed with a direction to the Inspector of Police, Batlagundu Taluk Police Station, to dispose of the representation of the petitioner dated 18.12.2020 within a period of two weeks from the date of receipt of a copy of this order/uploading of the order.
