This petition has been filed to extend the time to comply with the condition imposed in Crl.O.P.(MD)No.13609 of 2021 dated 20.09.2021.

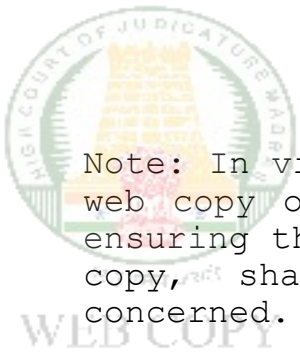
