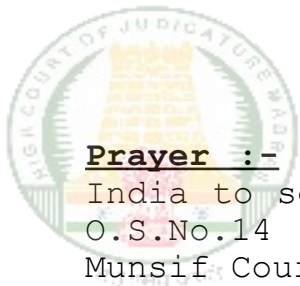

COMMON ORDER

It is informed by the learned counsel on both sides that towards the Arbitration Order No.113/1998-99 dated 22.05.2002, the Society has realised the dues by sale of the property belonging to the co-sisters of the petitioners in C.R.P.(PD) (MD) Nos.2652 & 2656 of 2014 and therefore, the Arbitration Order No.113/1998-99 has been satisfied. 3.In the light of the above, no further orders are required to be passed in these revisions and accordingly, the Civil Revision Petitions are disposed of on the above lines. No costs. Consequently, connected miscellaneous petitions are closed.
