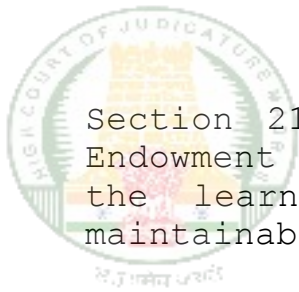

This revision arises out of the proceedings initiated by the Hindu Religious and Endowment Charitable Department for cancelling the order passed in favour of the petitioner Oil Company under



Section 21(A) of the Tamil Nadu Hindu Religious and Charitable Endowment Act, 1959. Very serious doubts have been expressed by the learned counsel for the respondents 3 to 6 about the maintainability of this revision.

2. I am not going into the said dispute inasmuch as the learned counsel for the petitioner has filed a memo stating that the revision has become infrutuous as the 6th respondent, who was appointed as a Trustee of the Temple which owns the land in question, has entered into a fresh lease agreement for a period of 3 years on 18.12.2020. The said memo is recorded and the revision is disposed of having become infructuous. No costs. Consequently, connected miscellaneous petition is closed.
