This petition has been filed seeking extension of time for executing the sureties as ordered by this Court in Crl.O.P.(MD) No.6698 of 2021 dated 12.05.2021.

The learned counsel for the petitioners submitted that suddenly, the first petitioner was affected with viral fever, due to which, the petitioners could not comply with the conditions as ordered by this Court. However, to show their bonafide, they are willing to deposit a sum of Rs.15,000/- jointly to any organization as directed by this Court.

4. Considering the submission made by the learned counsel for the petitioners, that they have not filed any petition for executing
