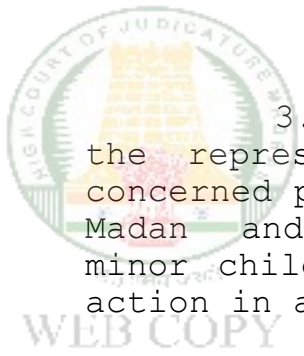

ORDER

The petitioner had given a representation to the second respondent complaining of this particular fact and the second respondent had marked the said representation to the third respondent namely the District Welfare Officer in the office of the Social Welfare Office of the District Collector office campus, Dindigul. A representation has been given by the petitioner to dispose of the petitioner's complaint.

A direction is issued to the third respondent to examine the representation of the petitioner, to issue notice to the concerned parties particularly to the son-in-law of the petitioner / Madan and also to the daughter of the petitioner and also to the minor child / her natural guardians and thereafter take necessary action in accordance with law.

4. With the said observations, this Writ Petition is disposed of. There shall be no order as to costs.
