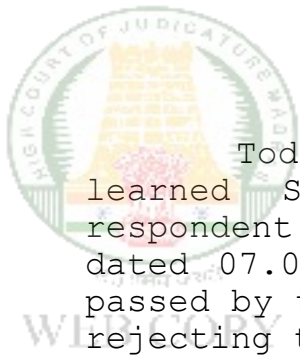
R-2 impleaded as per order of Court dated 15.11.19 in Sub A(MD) 280/2019
