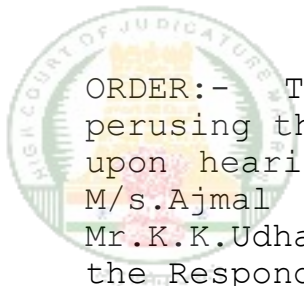

Prayer in W.M.P.(MD).No.19473 of 2021 :-

This petition filed under section 226 of Constitution of India to dispense with the production of the consequential impugned order passed by the 1<sup>st</sup> respondent vide his proceedings RC.No.06 / 10999/2018 dated 13/12/2021 and the impugned order passed by the 3<sup>rd</sup> respondent in the news paper namely Tamil Sudar published on 14/12/2021 vide his proceedings Na.Ka.No.489/2019-2021/Aa dated 14/12/2021.

Prayer in WP(MD).22977/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue WRIT OF CERTIORARIFIED MANDAMUS or any other appropriate writ or order or direction in the nature of writ calling for the records relating to the impugned order passed by the 1st respondent vide his proceedings R.C.No.06/10999/2018 dated 13.12.2021 and the consequential impugned order passed by the 3rd respondent in the news paper namely Tamil Sudar published on 14.12.2021 vide his proceedings Na.Ka.No.489/2019-2021/Aa dated 14.12.2021 and quash the same as illegal and consequential to direct the respondents to extend the period of license of the petitioner to run the TASMAM bar attached with the Shop No. 5169 situated in Solaiyalagupuram, Madurai district taking into consideration of the Covid-19 pandemic situation within the period that may stipulated by

In the captioned main writ petition proceedings of first respondent dated 13.12.2021 bearing Reference RC.No.06/10999/2018 *inter alia* setting out bar upset price *qua* areas adjoining various TASMAC shops and a newspaper notification dated 14.12.2021 bearing Reference No.ந.க.எண்.489/2019-2021/ஆ inviting tenders *qua* areas adjoining TASMAC shops have been called in question.

2.Adverting to the support affidavit in captioned Writ Miscellaneous Petition [WMP] Mr.H.Mohammed Imran of M/s. Ajmal Associates [Law Firm] submits that the impugned proceedings of the first respondent and the impugned notice of the third respondent inviting tenders dated 13.12.2021 and 14.12.2021 respectively were not served on the writ petitioner.

3.This is obvious as they are more in the nature of generic proceedings and tender notice inviting bids published in a local daily. Therefore, the reason in favour of dispense with prayer is good enough.

4.In the light of the narrative thus far, captioned WMP is ordered as prayed for.
