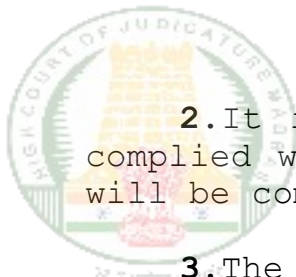
Prayer in WP(MD). 18694/ 2018 :
