**COMMON ORDER**

These Criminal Original petitions have been filed to set aside the order passed by the trial Court in rejecting the copy application filed by the petitioner.

2.The learned counsel for the petitioner would submit that instead of mentioning complaint copy, it has been wrongly mentioned as plaint copy. Taking note of the above defect, it came to be dismissed in entirety, even though Exs.P.1 to P 20 marked on the side of the prosecution, are available on records.



3.Let fresh copy application be filed before the concerned Court by setting out the correct particulars of the documents that sought to be issued, with certified copies.

4.In view of the above, question of setting aside the order of the trial Court may not be proper. With the above observation, these Criminal Original petitions are dismissed.
