By an order of this Court dated 13.07.2023, an explanation was called for from the learned Additional Sub Judge, Tirunelveli in respect of the non-disposal of H.M.O.P.No.8 of 2021 even though twice time was extended for disposal of H.M.O.P.

It is made clear that no further extension of time will be entertained by this Court.
