ORDER : The Court made the following order :-

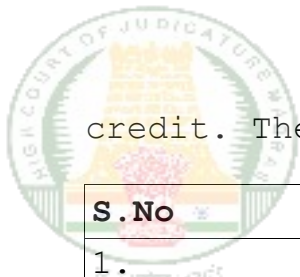

2.The case of the prosecution is that the petitioner along with other accused has illegally transported three units of red sand by using a Tipper Lorry. Hence, the complaint.

3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case.

4.The learned Government Advocate (Criminal Side) submitted that that the petitioner is having three previous cases to his
