3. Heard the learned Government Advocate(Criminal Side) appearing for the State.

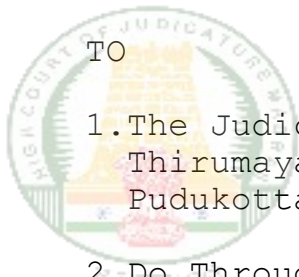
