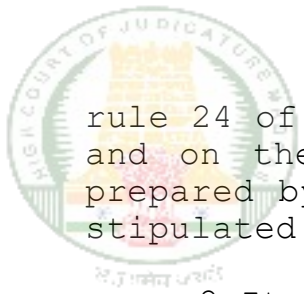

rule 24 of the Tamil Nadu Municipal Corporation Service Rules, 1996 and on the basis of the inter-se-seniority tentative panel list prepared by the first respondent, dated 23.09.2013 within the time stipulated by this Court.

2.It is represented that the issue raised in the Writ Petition is covered by the order passed in W.A.(MD)No.1411 of 2016. The issue raised in this Writ Petition is fixing of seniority in the post of Junior Assistant. The first respondent shall follow the order passed in W.A.(MD)No.1411 of 2016 and pass appropriate orders.

3.With this observation, the Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
