ORDER

This petition has been filed seeking a direction to the second respondent police to complete the investigation and to file a appropriate final report in Crime No. 604 of 2020 on the file of the second respondent police, within a period that may be stipulated by this Court.

2. The petitioner is the first accused. Based upon his complaint, a case in Crime No.604 of 2020 has been registered for the offences punishable under Sections 294(b), 323 and 427 IPC. The learned counsel for the petitioner submits that even after lapse of several months, there is no progress in the investigation. Hence, this petition.

3. The grievance of the petitioner is that the petitioner is selected for the post of Delhi Police Sub Inspector and awaiting for the posting order to be made after the contest is over.

4. The learned Additional Public Prosecutor would submit that investigation has been completed and final report is made ready on
