2.The learned counsel for the petitioner would submit that instead of Vattathikottai Police Station, it is stated as Peravurani Police Station and instead of Crime No. 324 of 2021, it is stated as Crime No.621 of 2021 in the relaxation petition and prayed the same to be corrected. He would further submit that the petitioner is complying with the condition from 27.09.2021, without fail.

3. The above submission is admitted by the learned Government Advocate (Crl. Side) appearing for the respondent Police.



4. Since the petitioner is complying with the condition without fail, the condition is fully relaxed. The petition is ordered accordingly.
