Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, by directing the second respondent to implement the order of the first respondent in his proceedings O.Mu.No.253/2021/H1 dated 30.02.2021 and signed on 30.06.2021 and to issue patta to the petitioner's land under his possession and enjoyment situated in Vallam Vadakku Serthi Village Natham Survey No.177 Part measuring 0.07 cents by considering the representation of the petitioner dated 30.01.2021 and to pass appropriate orders in accordance with law within a time frame to be stipulated by this Court.

ORDER

This Writ Petition has been filed in the nature of Mandamus seeking a direction to the second respondent / the Tahsildar, Thanjavur Taluk Office of Thanjavur to implement the order of the first respondent / the District Collector, Thanjavur which was passed on 30.02.2021 and apparently signed on 30.06.2021 in O.Mu.No.253/2021/H1.

2. In this connection, the petitioner had given a representation to the second respondent on 30.01.2021. However, it would only be appropriate that the petitioner files necessary application through online by paying the necessary and requisite fees for the same and on receipt of such proper application, an obligation is placed on the second respondent to invite the petitioner and examine necessary documents and make necessary inquiries and thereafter, pass necessary orders. The entire exercise shall be completed within a period of sixteen (16) weeks from the date of receipt of application by the petitioner herein.
