Prayer :-

This petition filed under Section 482 of Cr.P.C. To grant extension of time limit for a further period of four months in CrI.O.P.(MD) No. 18992/2019 dt. 21.12.2020 and CrI.M.P.(MD) No.3382/2021 in CrI.O.P(MD) No.18992/2019 dt. 29/06/2021.in Tirunelveli,CBCID Crime No.1/2017u/s.457 392 IPC(Mother Case in Panagudi P.S.,Crime No.377/2015)to complete the investigation and filing final report .

Prayer in CRL.O.P(MD) No.18992 of 2019:

Criminal Original Petition filed under Section 482 of Cr.P.C., to direct the first Respondent to file a final Report in Crime No.377 of 2015,Which was transferred from the Second Respondent herein within the time fixed by this Hon'ble Court.

ORDER:- This Petition coming on for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Thiru. M.Muthumanikkam, Goverment Advocate, for the Petitioner and of Thiru. M.B.K.Sudalayandi, Advocate for the respondent, this Court made the following order:

2. The Inspector of Police, CBCID, Tirunelveli, Tirunelveli District has filed the above petition seeking for extension of time for further period of four months, to complete the investigation in respect of the case in Crime No.1 of 2017 on the file of the CBCID, Tirunelveli and filing final report.



3. It is seen from the records that this Court vide order, dated 03.11.2020 has granted four weeks time to complete the investigation and file the final report and posted the matter on 02.12.2020 for reporting compliance. Subsequently, three months further time was granted vide order, dated 21.12.2020 and posted the matter 22.03.2021 for reporting compliance. Thereafter, this Court vide order dated 29.06.2021 has granted four months further time to complete the investigation and file a final report.

4. Considering the submission made by the learned Government Advocate (Crl.Side), this Court is inclined to grant a further period of three months time to the petitioners to complete the investigation and file a final report, from the date of receipt of a copy of this order.

5. Accordingly, this Criminal Miscellaneous Petition stands ordered.
