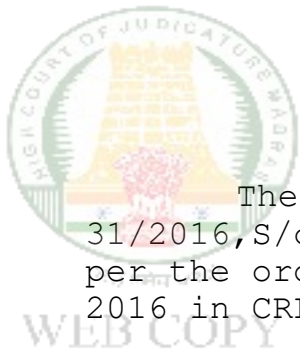




BAIL SLIP
