**PETITION FOR ANTICIPATORY BAIL
Under Sec.438 of Cr.P.C**

PRAYER :-

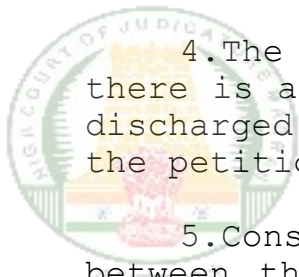
For Anticipatory bail in Crime No. 87 of 2021 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioners/accused Nos.1 to 3, who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 323 I.P.C. and 4 of TNPHW Act, 2002, in Cr.No.87 of 2021, seek anticipatory bail.

2.The case of the prosecution is that there was property dispute between the parties, due to that, the accused persons assaulted the defacto complainant and abused him in filthy language. Hence, the present complaint.

3. The learned counsel for the petitioners would submit that the petitioners are innocent. Injured was discharged from the hospital. Hence, he seeks anticipatory bail to the petitioners.



4. The learned Additional Public Prosecutor would submit that there is a property dispute between the parties and the injured was discharged from the hospital. No previous case is pending against the petitioners.

5. Considering the facts that there was property dispute pending between the parties, that the injured was already discharged from the hospital, that the petitioners are not having any previous cases for similar or serious offence and that except the offence under Section 4 of TNPHW Act, all other offences are bailable in nature, this Court is inclined to grant bail to the petitioners, with certain conditions.

6. Accordingly, the petitioners are ordered to be released on bail in the event of their arrest or their appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned Judicial Magistrate, Additional Mahila Court (Judicial Magistrate Level), Srivilliputhur on condition that the petitioners shall execute a bond for a sum of Rs.25,000/- (Rupees Twenty Five thousand only) each with two sureties, each for a like sum to the satisfaction of the respondent Police or to the Police Officer, who intends to arrest or to the satisfaction of the learned Magistrate concerned and on further condition that:

(a) the petitioners and the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(b) the petitioners shall report before the respondent police daily at 10.30a.m., for period of one month and thereafter as and when required for interrogation.

(c) the petitioners shall not tamper with evidence or witness either during investigation or trial;

(d) the petitioners shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]**; and;

(f) if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.

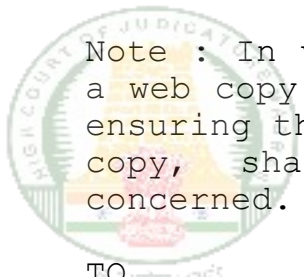
