PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Certiorarified Mandamus, to call for the records of the second respondent relating to his Order No.UXP/535/Stt. Misc. dated 11.03.2014, to quash the same and issue consequential directions to the respondent (i) to grant MACPS benefits to the petitioner w.e.f. 01.09.2008 in the light of Para 11 of Railway Board Circular RBE No.101/2009 dated 10.06.2009 defining 'Regular Service' and to treat the leave on 01.09.2008 as regular service and also revise his pensionary benefits and disburse all consequential monetary benefits with interest to the petitioner within a fixed time frame (ii) to grant First Class pass to the petitioner, in the lieu of second class pass.

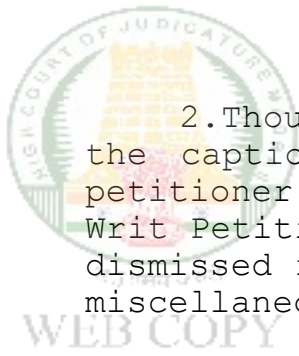
