ORDER

The third respondent will enquire the matter and conclude the proceedings within a period of two weeks thereafter. If at the end of the enquiry, the third respondent comes to the conclusion that FIR has to be registered, then, the petitioners will be given due notice and also breathing time, so that, they can move the concerned Court for the relief of anticipatory bail.

4. With this direction to the petitioners as well as the police authorities, this Criminal Original Petition is disposed of.
