2.It is seen that in the impugned order dated 11.05.2018, the Government Hospital, Annavasal Dental Unit along with the Dental Surgeon and Dental Assistant was shifted to the Government Hospital. The petitioner herein was a temporary Dental Assistant at Annavasal Dental Unit, which is the Dental scheme formed by the Government.

3.The learned Additional Government Pleader for the respondents, on instructions, submitted that the scheme itself has ended and the Annavasal Dental Unit does not operate as on date. As such, the order of the transfer of the petitioner has become



redundant, since he cannot seek for retaining him in a lapsed Dental unit.

4.The Writ Petition stands dismissed, accordingly. No costs. Consequently, connected miscellaneous petitions are closed.
