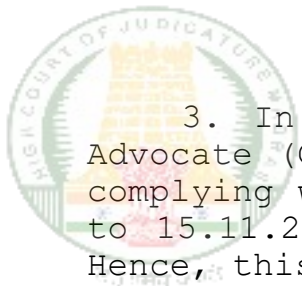

This petition has been filed to relax the condition imposed against the petitioner in Crl.O.P(MD)No.16145 of 2021, dated 28.10.2021.
