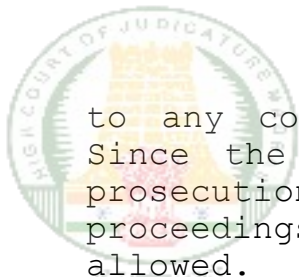

This criminal original petition has been filed for quashing the proceedings in C.C.No.215 of 2010 on the file of the Judicial Magistrate No.IV, Madurai.

2.The defacto complainant/Raja Mohamed is present before this Court in person. He has been duly identified by Mr.Syed Abdul Kadar, Sub Inspector of Police attached to Jeihindpuram Police Station. The defacto complainant states that the petitioners are his relatives and that he has decided not to pursue the complaint. All the petitioners are present before this Court.
