ORDER

This writ petition is filed seeking a mandamus directing the Secretary, Animal Husbandry, Dairying and Fishery Department/R1 and the General Manager, Tirunelveli District Cooperative Milk Producers' Union Ltd./R2 to conduct a written test for the post of Manager (Procurement & Input/Veterinary) intended to be filled up by the second respondent through advertisement bearing No.001/2017 dated 07.12.2017.
