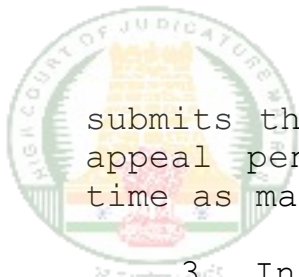

ORDER
