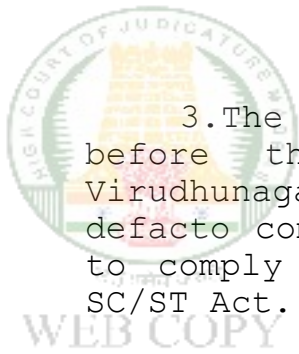
Prayer in CRL OP(MD). No.17596 of 2021
