Prayer: Writ Petition filed under Article 226 of the Constitution of India, for the issuance of Writ of Certiorarified Mandamus, to call for the records relating to the order Na.Ka.No.K2/33425/13 dated 06.01.2014 passed by the respondent and quash the same and consequently, direct the respondent to fix the pay of the petitioner in the post of Assistant in Revenue Department with due pay protection ie., at the last pay drawn of Rs.9700/- including the Grade pay as on 17.12.2012 and count the service rendered by the petitioner as Constable in the Police Department from 30.11.2003 a.n to 16.12.2012 as qualifying service for all the service and pensionary benefits.
