Prayer in WP(MD) No.21347/2021 :

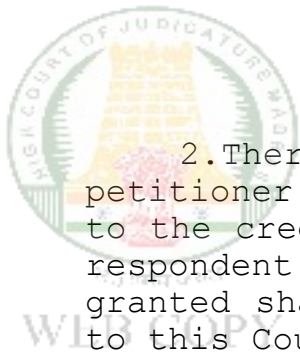
