If the petitioner has not been paid compensation so far, it is for the petitioner to move the first respondent by filing a representation in this regard. The said representation to be filed by the petitioner shall be considered and appropriate compensation will be paid to the petitioner herein within a period of eight weeks from the date of receipt of copy of this order.

2. With this direction, this writ petition is disposed of. Consequently, connected miscellaneous petition is closed.
