Writ petition filed under Article 226 of the Constitution of India to issue a writ of Certiorarified Mandamus, to call for the records of the 2nd respondent herein in his proceedings in Letter No.A2/2922/2016 dated 06.06.2018 to quash the same and to direct the 2nd respondent to promote the petitioner for the post of Superintendent on par with her Juniors with all benefits and back wages by including the petitioner's name in the appropriate place in the common seniority among the ministerial service employees working in the Department of Backward Classes, Most Backward Classes and De-notified Communities and Minorities Welfare.

Prayer in WP(MD). Nos. 8863 to 8866/ 2018 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus to call for the records of the 2nd respondent herein in his proceedings in Proc.No.A2/1695/2018-2 dated 13/04/2018 and consequent proceedings in proc.No.A2/1695/2018 dated 17/04/2018 to quash the same and further direct the 2nd respondent to include the petitioners name in the common seniority maintained among the ministerial service employees of the Department of backward classes, Most backward classes and De-notified Communities, and Minoriteis welfare and to consider the petitioner to promote for the post of Superintendent in accordance with the common seniority.
