The petitioner shall surrender before the jurisdictional Juvenile Justice Board on 17.12.2021. The jurisdictional Juvenile



Justice Board will obtain the report from the concerned probationary officer well in advance. The petitioner's bail petition shall be disposed of on the same day of surrender. The petitioner undertakes to comply with the requirements set out in Section 15(A) of SC/ST (POA) Act.
