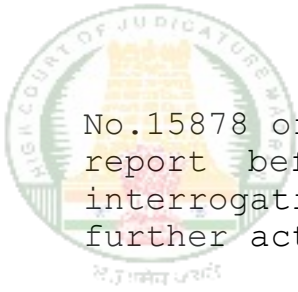
This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD)No.15878 of 2021 on 12.10.2021.

3.The learned Additional Public Prosecutor submitted that the petitioners have not been complying with the condition regularly and investigation is still pending.
