4.Considering the facts and circumstances and also the submission made by the learned counsel for the petitioner, the condition imposed against the petitioner is modified to the effect that the petitioner shall appear before the respondent police once in a week ie., every Monday at 10.30a.m., for a period of 6 weeks.
