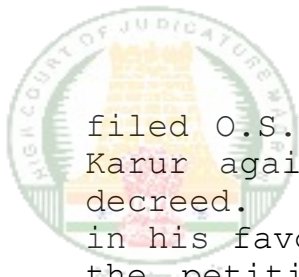
ORDER

If the petitioner obtains any enforceable order from the civil Court, he can definitely approach this Court for relief.
