Proceedings dated: 01.12.2021:

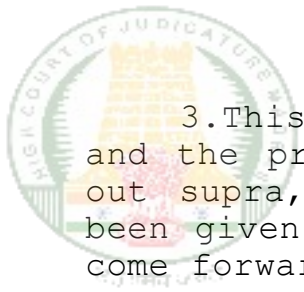
'Read this in conjunction with and in continuation of earlier proceedings made in the previous listings on 25.11.2021, 29.11.2021 and 30.11.2021.
