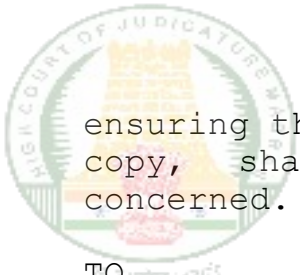
The learned Counsel appearing for the petitioner seeks permission of this Court to withdraw this petition through video conferencing.
