3.The writ petition is allowed on these terms. No costs.

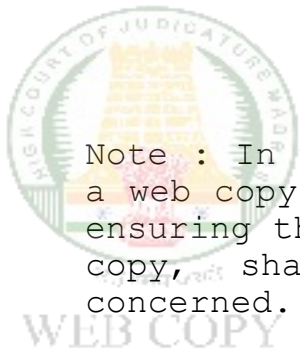
