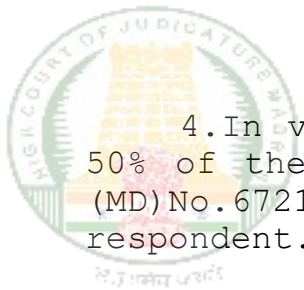
Prayer in CRL RC(MD). 671/ 2020 :

This petition has been filed to direct the Family Court, Sivagangai to permit the petitioner to withdraw 50% of deposit amount deposited in M.C.No.62 of 2018.

2.On the side of the petitioner, it is stated that the petitioner may be permitted to withdraw the deposit amount and prayed to allow the petition.
