The learned Counsel for the petitioner would submit that the petitioner was directed to pay Rs.10,000/- to the Green Committee, Madurai, while granting anticipatory bail and since the said Committee was not constituted till now, he could not able to pay the said amount and hence, he could not surrender before the learned Judicial Magistrate concerned and produce the sureties within the stipulated time as prescribed by this Court.

3.Considering the submission made by the learned counsel for the petitioner, this petition is allowed and time is extended by 10 days from the date of receipt of copy of this order.

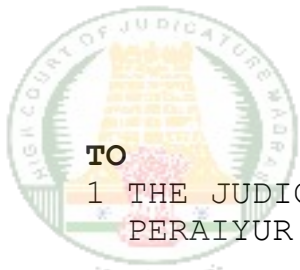
